

BURIAL DISCOVERY AGREEMENT APPLICATION INSTRUCTIONS

Section 1. Types of Burial Discovery Agreements

- 1. **Standard:** for all projects located within the management areas of the Gila River Indian Community, the Salt River Pima-Maricopa Indian Community, and the Tohono O'odham Nation for which you anticipate that you will encounter primarily O'odham, Hohokam, and/or Archaic cultural contexts.
 - a. Gila River Indian Community: north of Toltec, Arizona and south of Baseline Road, Phoenix, Arizona
 - b. Salt River Pima-Maricopa Indian Community: north of Baseline Road, Phoenix, Arizona
 - c. Tohono O'odham Nation: south of Toltec, Arizona and southwest of Buckeye, Arizona
- 2. **General:** for projects managed by a municipality or that are within one of the historic cemeteries specified below.
 - a. City of Phoenix: for projects sponsored by the City of Phoenix

Section 2. Burial Discovery Agreement Application Materials

- b. City of Tempe: for projects initiated and conducted by the city and also for projects on city land
- b. Court Street Cemetery: for projects on state or private land within the boundary of the cemetery
- c. Kingman Pioneer Cemetery: for projects within the boundary of the cemetery
- d. Pima County: for projects initiated by the county on state and private lands
- 3. **Project-specific:** for agreements that do not fall under the project types listed above.

Pease note that different types of Burial Discovery Agreement applications require different supporting materials.	
All Burial Discovery Agreement applications must include the following:	
☐ A Burial Discovery Agreement Application form	
A USGS map at 1:24,000 scale, neither enlarged nor reduced, of the project area(s) and site(s) to be investigated	
For projects to be completed under a general work plan attach:	
☐ A Repatriation Office General Work Plan Addendum form	
For projects seeking to use the Phoenix or Pima County General Burial Discovery Agreements include:	
☐ Permission from the appropriate municipality to use a General Burial Discovery Agreement	
For projects to be completed under a project-specific treatment plan include:	
A copy of the project treatment plan. This treatment plan must include field and lab methods for the recovery and documentation of remains.	
If a BDA application is being submitted along with an application for a AAA Permit, a digital copy of	
the work plan must still be submitted to the Repatriation Office along with the digital Burial Discovery Agreement Application.	y
Projects located solely on private land do not require a work plan. For projects located solely on private land attach	:
☐ A Repatriation Office Private Land Addendum form

Section 3. Submitting Burial Discovery Agreement Applications

1. Burial Discovery Agreement applications and supporting documentation may be submitted digitally. However, the original, signed application and a hard copy of the final, ASM-approved treatment plan, if applicable, must be mailed within 30 days of agreement issuance.
